



## Mae Fah Luang University Announcement

Re: Regulations and Criteria for Graduate Student Publication (Third Issue), B.E. 2565 (2022)

Mae Fah Luang University considers it appropriate to revise its criteria, requirements, and guidelines for publication of post-graduate research as a requirement for curricular fulfillment, in order to ensure greater consistency with the current situation and compliance with Mae Fah Luang University's standards.

By virtue of section 26 of the Mae Fah Luang University Act, B.E. 2541 (1998), and the resolution of the Postgraduate Committee in meeting no. 12/2564 dated 24 December, 2021, and the resolution of the Academic Council in meeting no. 1/2565 dated 5 January, 2022, the University hereby issues "Mae Fah Luang University Announcement Re: Regulations and Criteria for Graduate Student Publication (Third Issue), B.E. 2565 (2022)", as follows:

No. 1 This announcement is referred to as "Mae Fah Luang University Announcement Re: Regulations and Criteria for Graduate Student Publication (Third Issue), B.E. 2565 (2022)".

No. 2 This announcement is effective after the date of issue.

No. 3 The statement in item 10.3 of Mae Fah Luang University Announcement Re: Regulations and Criteria for Graduate Student Publication, B.E. 2560 (2017), dated 21 August, 2017, is revoked and replaced with the following statement:

" 10.3 For research articles presented at a conference or published in the proceedings, students are required to submit the following documents:

- 1) A copy of presenter certification or an equivalent document to prove the students' presentation on the conference day(s),
- 2) A copy of the proceedings cover page,
- 3) A copy of the table of contents where the students' research paper appears,
- 4) A copy of the full research paper published in the proceedings,

5) A copy of a page presenting the list of editorial board members or the conference's organizing committee members and their affiliations,

6) A copy of evidence to prove that the research article has been reviewed by specialists in the particular field of the research. Moreover, at least 25% of articles in the proceedings are from at least 3 external organizations (for national conferences only),

7) Should the presenter receive an award, attach some evidence i.e. certificate, accreditation letter, etc.

Should the full paper be published in a proceeding in a SCOPUS database, students may submit the publication acceptance letter together with the full paper instead of the items 2), 3) and 4) above.

Students must present at a conference prior to the submission of their publication document submission for graduation.”

No. 4 The President is acting on behalf of this announcement and has the authority to make any final decisions concerning the implementation of this announcement. The President's decision is final.
